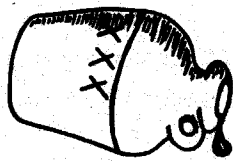

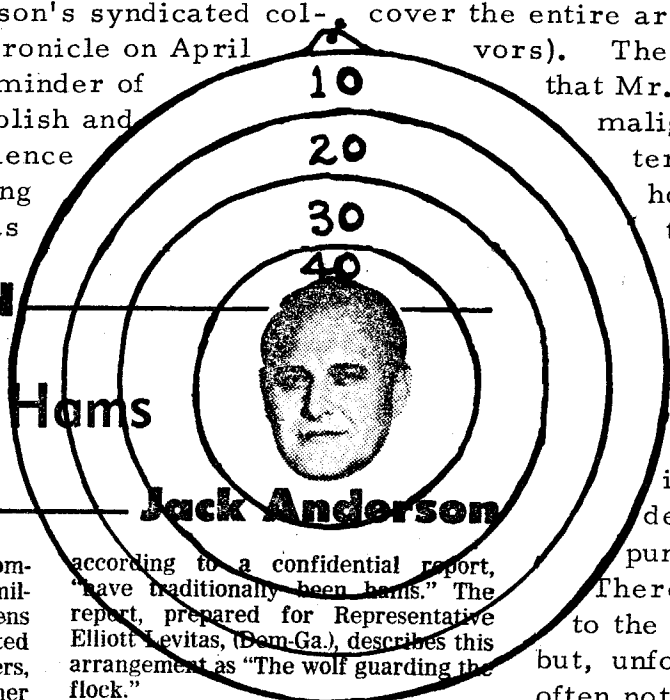

that did not have apparently enough space to cover the entire article (thanks for little favors). The problem is, of course, now that Mr. Anderson has nationally maligned the amateur radio fraternity in one, fell swoop, just how do we go about righting this atrocity?? Let us hope that our ARRL is adequate to cope with the problem. It appears that the electronics industry certainly must have an enormous amount of lobby power in order to influence a writer of Mr. Anderson's calibre to write such punishing lines.

**T**HE Federal Communications Commission is quietly stifling the millions of voices that jam the Citizens Band radio frequencies. An estimated nine million licensees — truck drivers, teenagers, housewives, even a former First Lady — now operate more than 20 million CB sets. The airwaves have become so crowded that the CB industry has appealed for more frequencies. These would have to be taken from the ham radio operators, who add up to no more than 300,000. Yet the commission has favored the few over the many.

The 300,000 hams have 100 times more airspace than is available to the nine million CB enthusiasts. The hams also have a lock on the higher frequencies, which are free from interference.

**A**CCORDING to one confidential report, the hams now control more frequencies than all the nation's police and fire departments combined, plus all commercial and educational FM broadcasters, plus all the TV stations on the VHF channels in Los Angeles and New York City.

The telecommunications policymakers at the White House have quietly notified the Federal Communications Commission on three occasions that there would be no objections to expanding the airwaves for the CB users.

Still, the commission has refused to take the hint. One reason may be that CB radio is regulated by officials who,

according to a confidential report, "have traditionally been hams." The report, prepared for Representative Elliott Levitas, (Dem-Ga.), describes this arrangement as "The wolf guarding the flock."

The opposition to giving the CB industry a greater share of the airwaves has been generated largely by the American Radio Relay League, which the report describes as "a lobbying organization" representing ham operators.

The league has fired off a special "flash bulletin" to its members, urging them "to utilize every league resource" to prevent the incursion of CB buffs into their airspace.

**Footnote:** The Federal Communications Commission's chief engineer, Raymond Spence, is a lifetime member of the league. Yet he has made decisions detrimental to the CB industry. He denied that his membership is a conflict of interest.

**T**HE MAIL to President Carter has passed the flood stage. In desperation, the White House has called in emergency help from two federal agencies. The Veterans Administration has rushed over 27 secretaries and clerks; the Health, Education and Welfare Dept. has contributed another 20 employees to help process the mail. Spokesmen assured us that the sudden increase in the population of the White House is "temporary."

There have been articles, letters to the editor of some of the papers but, unfortunately, these are most often not read by the majority of the readers as those who read the "big" columns. Jack A. Holmes, W6RCP of Santa Clara wrote to the San Jose Mercury and his last paragraph of his letter to the editor reads: "Mr. Anderson got into an area here where I have many years of experience and it is obvious to me he didn't do his homework on this one, so I can't help wonder how many times he has led me astray in areas where I am not so experienced."

It makes this editor wonder, too.

NEW FCC REGULATIONS AND RULES.....

Do not have the actual text of the FCC ruling, but the heart is as follows: as of April 15th -

- a) Amateur radio transmitters MUST have all harmonic output at least 40db down.
- b) It will be illegal to buy, sell, trade a linear amplifier that has a total plate dissipation of more than 1,000 watts. This apparently does not apply to private sales.

BE SURE that your station conforms to these new rules and remember that if you crank up that old amp to its limit, the harmonics et al gets pretty bad. Hope to have some info at the April meeting concerning testing/checking of our rigs for meeting the spec.

are also licensed to the op and station, so you proceed to get two additional Q's. This does provide you with a definite advantage over the other competitor who does not know all these "extra" calls. The second point is first explained by W6RTT at the Fresno Contest Forum as running "power". With the current level of commercial amps in use, it is fairly easy to run a bit "extra", for whatever it gives as an advantage. Both of these subjects have been discussed already at length and fall under the new category of "Contest Ethics". It seems only right and fitting that the great contest club on the west coast, the NCCC, take the lead in this ethical matter and set the standard for contesting. Let us all take a moment or two and review our own feelings and we will probably find that contesting would be even more exciting with everyone by a good code of ethics.
