THE LEGEND CONTINUES . . . . . NCCC WINS 1983 CQWW!!!

The October CQ, soon to hit the street, will proclaim that the Northern California Contest Club topped all other clubs in the world in the 1983 edition of the biggest, baddest DX contest, the CQ Worldwide! Thus, we repeated our triumph of 1981. The scores of the leading clubs look like this:

NCCC	113 Million points
Frankford RC	98 M
Yankee Clipper CC	85 M
Southern Calif. CC	35 M
Potomac Valley RC	33 M

Farther down the list, the NCDXC registered 12M. We did it with 19 DXpeditions in 1983, compared with 22 in 1981. The official SSB results show that Rich Smith, N6KT, won the world in the single-op category from PJ2FR. Gary Caldwell, WA6VEF, operating from AI6V, was number one in the USA, and, almost beyond belief for a West Coast station in a declining sunspot year, set a new record in the process. T11C, with NCCC ops K6HNZ, W6SZN, W6TPH, and AE6U, is sitting on top of the world in the multi-multi category.

#### MINUTES OF THE **august** 24, 1984 NCCC MEETING

The **august** 24, 1984 meeting of the NCCC took place at Harry's Hofbrau in Palo Alto. President Ed, AJ6V, called the meeting to order at 8:21. Introductions of the more than 50 people present disclosed the following guests: WA6AZP, KB6WP, KE6D, K6LLK, KA6IMC, 3B8CF, N6IFD, WB6MZQ, AA6UO, AG6Q and numerous wives and girlfriends.

New members WA6AZP and WB6MZQ were elected to membership unanimously. Former member AA6UO was reinstated by unanimous vote.

Announcements concerning the upcoming sprints were made by N6XI (CW) and K6KLY (SSB).

Bob, W6RGG, then presented awards for the 1983 CQ WW CW and SSB weekends to Lloyd and Iris, W6KG and W6QL. Following the presentation of the awards, Lloyd and Iris presented an excellent and entertaining program on their operation from the Sultanate of Oman.

GET ON THE CQP BANDWAGON!!

It is September and the beginning of the fall contest season is upon us once again. What better way to start off than the NCCC sponsored California QSO Party? Our state QSO Party is the best in the country according to many, and your activity will help to keep the CQP number one among the many state QSO parties which occur during the year. This is also an excellent opportunity to sharpen up your operating skills for the big SS effort in November.

As in the past, the CQP will be held on the first full weekend of October: October 6 and 7, 1984. Starting time is 1600 UTC October 6, and the contest ends 30 hours later, at 2159 UTC October 7. Single operators may operate 24 hours out of the 30 hour period, and time out periods must be at least 15 minutes long and noted in the log. Multi-operator stations may operate the full 30 hours period. Out of state stations work only California stations; California stations work anyone.

Suggested operating frequencies are: 1810 and 60 KHZ up on 80-10 meters (except 30 meters) for CW; and around 1810, 3900, 7230, 14280, 21360, and 28600 on SSB. CW QSO's must be made in the CW sub-band (except 160 meters). Please try to avoid net frequencies. Mobiles may be worked again if they change counties, and a station may be worked once on CW and once on SSB on each band. Try 10 meters on the hour, and 150 meters at 0500 UTC. The exchange is QSO number and county for stations in California; QSO number and state, province or country for stations outside of California. There are 58 possible multipliers; the 50 U.S. states and VE1-VE7 and VE8/VY1 for stations in California, and the 58 counties in California for out of state stations. Scoring is two points for a complete QSO on phone and three points for a complete QSO on CW. Multiply total QSO points times multiplier.

Highest scoring single operator in and out of California will receive a plaque, and the high scoring expedition stations, single and multi-operator will also receive a plaque. Certificates to highest scoring single operators in each county, state and country. Logs must be postmarked by November 7, 1984 to be eligible for awards. Send logs to: Alan A. Brubaker, K6XO, 3675 El Grande Drive, San Jose, California 95132. Expeditions and mobile operations are encouraged, and an effort will be made to activate all 58 California counties. Several mobile stations are expected to be active, and several expeditions are planned as well. If you are interested in going on an expedition, and do not have a particular destination in mind, give me a call at 408-741-5900 (days) or 408-272-8873 (evenings) and I will have a list of counties which need activity. Good luck to all and enjoy the CQP.

The Board took the following action:

1. In view of NCCC's resounding victory in the 1983 CQWW, AUTHORIZED Finance Chairman WA6AUE to sell T-shirts commemorating same to the membership, and to provide suitable sparking refreshment at the September 24 meeting.
2. AUTHORIZED an SS awards program, and requested N6TV to prepare an article detailing same for the September Jug. N6TV will obtain SS logs and dupe sheets.
3. 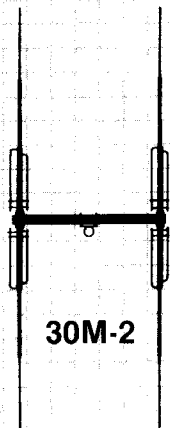

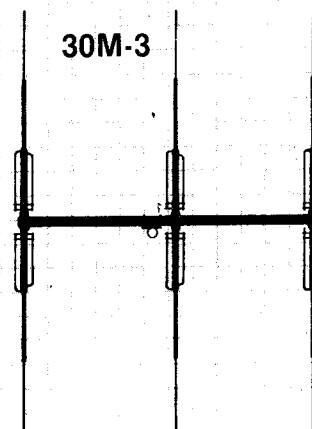
