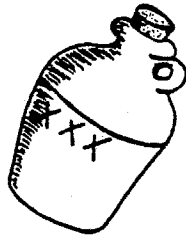

PETE'S PREDICTIONS

During this summer period while operating activities are low and the weather is good it's time to make some of those antenna and station improvements you have been thinking about. Too often many of us are caught putting up antennas or making station modifications on the starting day of a major contest. The usual result is exhaustion by the time the contest starts, or unexpected bugs in the system with no time left to correct them.

If you get your antenna work done now you will have plenty of time to test performance and make additional modifications if necessary.

Take your memory back to last season and consider the operational features of your station which need improvements to increase operating efficiency and reduce operator fatigue. Make a list of needed changes and get started on them. To meet our goal of 20 Meg in the 1979 SS and to win the 1980 ARRL DX 'test, all of our stations will have to be operating at top efficiency.

However, Gary should not get the blame for the poor response time for the results. The person who promised us the results time and time again was George, WB6DSV. It seems he was struck by Cupid's arrow or something like that. The club has suffered a great deal of bad publicity regarding this affair, and it is good that it is over. Hopefully, next year's results will be somewhat more prompt.

ANOTHER NA SPRINT

Yes, folks, it is indeed time for another North American Sprint contest, the contest sponsored by the National Contest Journal. The contest, to be held the evening of Saturday, Sept. 8, will hopefully be the best yet.

The rules for this contest are the same as for all previous ones, but, in case you just tuned in, I will recap them for you. First of all, it is CW only I know that just eliminated 50% of the club, especially those that attend San Jose State, but, for the rest of you, here we go. Contest activity will be on 20, 40, and 80 meters, with suggested frequencies about 30 to 50 kHz. up from each band edge.

The exchange for the contest is as follows. To be a valid contact, each QSO must contain this information: his call, your call, a serial number (beginning with 001), your name and state. An example follows:

N6HT de WA6VEF nr 203 Gary CAL K
WA6VEF de N6HT nr 002 Glenn CAL Z
The info need not be in that order, but must be contained nonetheless.

One interesting facet of the 'tes. is the "QSY" rule. It states that once you call CQ, QRZ?, QRZ, Z, etc., and someone calls you and you proceed to QSO him or her, you must QSY at least 5 kHz before calling another CQ, or at least 1 kHz, before working another station.

Perhaps the best part of the contest is the team competition. A team consists of 10 amateurs. That is the only requirement, no meetings, no minimum distance, etc. Oh, yes, the team list must be in the hands of N6SF at least 24 hours before the start of the contest to be eligible for awards. This must be done by either first class mail (better mail early) or by a Western Union mailgram (No singing ones, tho), dated at least 24 hours before the start. Teams compete, with the winning team getting awards for all of its members, and all teams' highest scoring operator gets a certificate.

The time????? Oh, so you thought I forgot. Well I did, but it goes from 0100Z to 0500Z (or, 6PM to 10PM local) Here's hoping to see you in the sprint

QUESTIONNAIRES

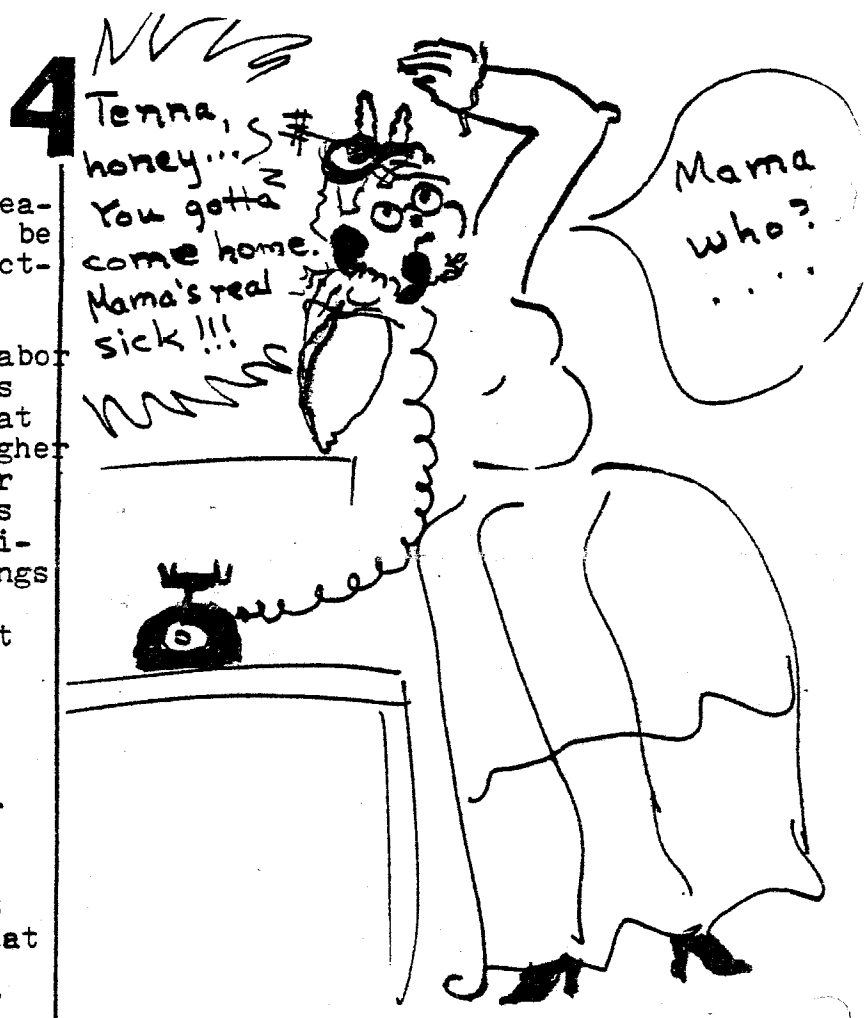
