## **October Meeting Webinar**

The October meeting was a very interesting and fun gathering that was shared by more than those in attendance at the TechShop. The meeting was simulcast using the club's Webinar technology. The interesting story is how this came to pass, and what it holds for the future.

Credit for the idea belongs to Hank Garretson, W6SX, who first broached the idea a few months ago. Hank suggested that should look for ways to extend our meetings to those away from the gathering. This usually means those quite a distance away from the Bay area, such as members north and east of Sacramento, or in Hank's case, out in the beautiful area of Mammoth Lakes. The discussion began with a live video Webcast, and progressed through various methods using internet technology. There are several problems that needed to be overcome with each of the methods, not the least being the lack of Internet connectivity at most of our meeting locations.

Things fell into place for the October meeting. This meeting was held at the TechShop in Menlo Park. The TechShop has very good facilities for those building things, from plasma cutters to all sorts of metal shaping equipment. It also has very good Internet connectivity. With this in mind, we decided right after the September meeting to put things together for the October meeting. Our discussions concluded that using the club's Webinar facilities should provide a very good test.

To do so we would need a good audio and computer system that would allow us to display the presentation slides and presenter's sound. There were many variables in the plans, and our confidence in things going right the first time was not very high. With this

in mind we posted a short notice to the NCCC email list with the provision that technical difficulties might disrupt our plans.

The plans were rather well laid out. Audio expert, Jim, K9YC, volunteered his wireless microphone system and services to provide meeting audio. Our resident Webinar guru, Dean, N6DE, guided us with setting up the computing equipment for the Webinar. The day before the meeting, N6DE, N6NZ and W6FB gathered at the TechShop to test the system.

A standard presentation environment uses a portable computer (in this case a MacBook Pro) with a video projector. The Webinar adds the audio and network interfaces to allow network viewers to participate. It was a good thing we decided to test the system before going live. The first projector did not work, but a second projector gave us a great projected image of the PowerPoint slides. We then had to find some combination of PowerPoint and the Webinar software that allowed the best view for both those gathered at the TechShop and the Web attendees. After several attempts we finally settled on a setup that was a good compromise for both sides. With all this now set, we went home with more confidence that we may actually be able to make things work.

The day of the meeting was the first time we actually had all the pieces together. K9YC had his equipment assembled and ready for operation. It plugged right into the USB audio processor for the computer. After some testing, we quickly determined the right settings and connected things together. This was actually the first time everything was together and working well. The presenters each had a wireless microphone, and K9YC used a handheld microphone to gather audience sound. Audio was one-way only, with no sound hookups to be able to listen to audio from the Internet audience. Web feedback was intentionally limited to messages using the Webinar chat software.

By all accounts, the Webinar achieved all our goals and then some. The meeting Webinar was a resounding success, with quite a bit of feedback during and after the meeting. For those who wish to view the meeting recording, it is available at the NCCC Website - you can see for yourself our Sweepstakes plans and develop your own opinion as to how well the presentation technology did.

So, can we expect more Webinar simulcasts in the future? We certainly hope so. There are many variables that must be overcome. Unfortunately, most meeting locations do not have good Internet connectivity, which is a must for the Webinar to succeed. We have to have volunteers to help with the presentations, including someone handling the Webinar software, and a second handling audio.

Observation of K9YC during the October meeting showed him constantly adjusting audio levels to provide the best sound. Of course, if we wanted to also provide meeting video, we would need someone to handle the camera and great lighting for the cameras. In short, we need volunteers to put on the production, and the right meeting location that can support the effort. Most of our planned meeting locations do not provide great facilities for this, but we will be looking at this in the future as we plan meetings.

Thanks to W6SX for the excellent suggestions, to N6DE and K9YC who made the production possible, and to the TechShop for the excellent facilities.

## The Upcoming Sweepstakes

Right on the heels of CQP comes the first major domestic contest of the season – Sweepstakes. At the October meeting, those who attended or participated in the Webinar had a chance to see and hear some solid strategies for doing well in SS 2010 CW and phone.

Behind the “members only” section of the Website are great references, in particular, Bob Wolbert’s (K6XX) SS Primer. You’ll have access to the latest propagation projections from Dean Straw (N6BV) and other sources of good information relating to this and other contests.

Unlike CQ WW at the end of the month, or other international contests, you don’t need a KW and a yagi to do well in SS. You need patience. You need to motivate yourself to stay at it for as long as you can in each 24 out of 30 hour stint. You also don’t need to have great capabilities on six contest bands. You can do extremely well working three bands – 20, 40 and 80. And, when sunspots are promising, as they appear to be this time out, you can do well on 15, 20, 40 and 80.

What makes SS different than nearly any other contest is a limited number of multipliers (80) and a limited number of participants (US and Canadian stations, only). That means, even the most powerful combination station/antenna/operator players will run out of people to work by the end of the contest, if not before. You can work a station once, period. And, it doesn’t matter if you work that station on any of the bands.

As Dean Straw (N6BV) likes to point out, if the propagation gods are smiling at us, starting out on 15 may be a lot better move than kicking off on 20. At 1 PM local, if 15 is productive, it favors west coast stations working the population centers east of the Mississippi. For the right coasters, the skip takes them into far less populated states before hitting California. In fact, it probably makes sense to listen on 10 this time out, too, as it has been open and productive at times this Fall.

Regardless of what kind of station you’re using, be prepared to do both running and S&P. Even the perennial champion ends up S&Pping as he runs out of stations to work. If you are using spotting, keep an eye out for the mults that you need. Don’t rush to a spot to work someone, though, because there will be a huge bulge, at first. And, don’t worry about running and missing some of the loud “runners” you heard up and down the band. They’ll either still be there, later, or they’ll come looking for you.

If you use prefill logs, be careful! Make sure you listen to the exchange and compare the data that pops up with what the other station sends. You’ll be surprised how often prefill data is wrong.

Don’t get discouraged if you are not achieving a huge rate at any time. Keep in mind that at the end of 24 hours of operating, if you have 1,000 Qs you’ve done a creditable job. That’s an average rate that is less than 50 per hour. So, if you have a 60 or 70 rate, and

later you drop down to 40 for a while, that's okay. If you rate starts to sink, early, change something (e.g. your frequency, your band, running-to-S&P or vice versa).

The SS contest is a linear score contest. The longer you operate; the higher your score. So, again, be patient, sit in the chair, and keep up the good work.
