VPCC'S SPOT

With the VHF (SO Party and the All Asian Phone Contest now behind us, the summer contest season is already halfway completed. I was extremely pleased to hear so many NCCC members active in the VHF 'test and AA, and I hope that this level of enthusiastic participation continues for Field Day, the North American Sprint, and the IARU Radiosport Chamionship—all happening in the next month.

The active corps of NCCC has decided rather unanimously not to participate as a club in Field Day this year—except for the mobile club aggregate catagory. We've won this FD catagory for 3 years now, and I see no reason why we can't take the national mobile title for the fourth consecutive year. The best way to contribute points to our club mobile total is to use 2 meter FM, operating mobile from a hilltop (or even from the home driveway!!). By using 10 watts input or less, each QSO is worth 5 points. If you do make a mobile Field Day effort, be sure to submit your entry to the ARRL. The mailing deadline for all Field Day entries is July 24, 1978.

The NCJ-sponsored North American CW Sprint is sceduled for July 2nd (complete rules in last JUG). The Sprint offers an excellent opportunity to sharpen one's search and pounce skills, as the rules are written to prohibit any station from calling CQ and then working more than one station on a given frequency without QSYing. There is team competition for this event, each team being allowed no more than 10 entries. If you'd like to be a of a KB team, please contact me, either at home at 538 0520, or at the June meeting.

Remember, this repeater offers our club the potential to tie together our members in a way we've never been able to do before. This repeater is ours to use too, 24 hours a day, except for a few periods where we become number two! First priority for use for our new repeater goes to Lameda County Radio Amateur Civil Emergency Service (ACES) for their weekly Monday evening net (1900-1915 local time), exercises, drills and tests held at random times and dates (never during contests!). and genuine declared emergencies.

For making the repeater available to RACES, we receive a secure site and A.C. power at no charge. We then agree to maintain the repeater at no expense to the county.

Considering what some other repeater groups pay for rent and power, we have a very good deal, plusthe opportunity to provide a public service to the opulace of Alameda County and to many others by providing access to a 24-hour open repeater.

As you may have guessed by now, the maintenance referred to above is not without cost. Some twenty plus members pledged in excess of \$300 at a recent meeting to pay for the complete overhaul and retubing of the machine by WAGEUZ.

Since that time, it has been determined that the duplexer is deffective, out of warranty, and nonrepaiable. That's why the repeater is currently operating using two seperate antennas (for receive and transmit).

"What's wrong with that?", you may ask; "Why do we need a duplexer?" Well, two antennas require two feedlines. Long runs of high-quality, low-loss feedline are a must for a high repeater antenna. It's much cheaper to buy one length of good feedline to

95129)? If we get all the renewals in soon enough, go to one antenna. In addition to the extra feederage of the repeater between transmit and receive becomes non-reciprocal. In other words, the higher receive antenna hears farther on receiving than the transmit antenna reaches on transmitting. If that's not bad enough, the lower antenna is distorted by the tower extending above it.

N6CN, N6TU and N6IG are currently exploring the possibility of building our own duplexer with three surplus cavities received from another county via RACES. If they prove to be usable, we'll have three more built and combine all six cavities into a usable duplexer. If they don't work, we'll have to buy a new duplexer. A model which meets our objectives costs about \$650.00.

In addition to the duplexer, we need a full set of spare tubes and miscellaneous parts in order to keep the down time to a minimum. There is no way our club treasury can handle these expenses, therefore, a separate fund will have to be maintained.

Alameda County RACES members, some of whom are not even licensed amateurs, have shown great interest in supporting the maintainance costs and the duplexer cost, should that be required.

I call upon all of you NCCC members who haven't done so to send \$1, \$10, \$25 or whatever to the repeater fund. The funds will be used to keep both the VIF and UHF repeaters on-the-air. Send your contributions to Secretary/Treasurer W6LH.

Complete rules are in May QST.

At its January meeting, the ARRL Board of Directors voted to study the Headquarters Awards Committee. It passed a motion, reported as Minute 27 (Mar. QST, P. 58) which reads "The Membership Affairs Committee is directed to study the function and composition of the Headquarters Awards Committee and to report its findings at the July meeting of the Board."

Our own Pacific Division Director, W6ZM, serves on the MAC and has solicited the club for its input on this topic. The HAC serves as an advisory body to the Communications Manager in matters concerning ARRL sponsored contests and awards, so it behooves the NCCC to give the matter some thought and to send Bill to the July meeting armed with some input.

Perhaps the greatest impact the HAC has on us as contesters in in the area of disqualifications. Its members review questionable logs and make recommendations to the CM as to whether or not particular entries should be disqualified. Personally I have no doubt that the HAC has no axes to grind and that it makes its recommendations in good faith. However, there are occasions when some entrant honestly believes his disqualification was unfair, or he wishes to challenge his disqualification for some other reason. He usually finds himself in the frustating position of being faced with a fait accompli - QST has already gone to print with the news of his demise before he ever had an opportunity to discover the reasons for which he was disqualified or before he could rebut the charges. He is faced also with the problem of to whom he should direct the rebuttal. Certainly, the CM is the one with the ultimate authority to rule on the disqualification but does not the very nature of the close working re-
